

# **GENERAL INFORMATION**

## **MEETING CANCELLATION AND REFUND POLICY**

Refunds are provided according to the written refund policy established for the program you are canceling. This policy, along with the procedure to follow to obtain your refund is published on the program brochure, IPGE Web Site, and the registration acknowledgment we send to you. If IPGE cancels a meeting, you will receive a full refund unless cancellation is due to natural disasters (fire, flood, strikes, acts of war or terrorism, or any other cause beyond our control). In this event, a tuition credit is issued valid for a minimum of two years.

## **TUITION REFUND PROTECTION PLAN**

For a non-refundable fee of \$35.00 you may assure a full refund of tuition fees paid until the day before your seminar is scheduled to begin. The waiver option must be purchased at the time of registration, and is not available less than 10 days before any meeting is scheduled to begin.

## **TRANSFER OF REGISTRATION**

If you did not purchase the refund protection plan and you must cancel, it may be more cost-effective to transfer your registration to another IPGE program offered within one year of the date of cancellation.
